### **COLLECTION OF PERSONAL DATA**

THE HUNT MANAGEMENT collects the following information:

Last Name, First Name;

Gender;

Date of Birth, Age;

Address of Social Network Profiles;

Email Address;

Country and City of Residence, Address, Phone Number;

Nationality;

Level of Education;

Physical Description.

The personal data that we collect are collected through forms and thanks to the interactivity established between you and our WEB company.

Your personal data are collected through forms, namely:

- Website registration form;
- Book edition form (or public profile) or any other (survey, contest for example).

In particular, we may use the personal information you provide us in connection with your name, date of birth, address and other information related to your registration or use of our services;

We also have access to information related to your location from your IP address as well as technical information relating to the device you are using including the type of web browser.

Under no circumstances will the information collected be divulged or shared with third parties, natural or legal persons other than the personnel attached to the agency's mission.

When you accept our privacy policy, you give us the right to collect this information and to use it in accordance with the purposes of the services we have undertaken to offer in return for the information you provide.

## **DISCLOSURE OF THE INFORMATION COLLECTED**

Except for the employees and duly authorized representatives of THE HUNT MANAGEMENT as well as its partner agencies and other professionals associated with the agency's mission, THE HUNT MANAGEMENT does not disclose to third parties outside the website any information collected without your prior consent. The information collected is only visible and used by them who will have legitimate access to your file and this, in the strict exercise of their duties.

## **RIGHT OF OPPOSITION AND WITHDRAWAL**

We undertake to give you the possibility to oppose the communication of your personal data to certain third parties, even if they are modelling or image professionals. You also have the right to demand the withdrawal of any of your personal data (Right of Opposition and Withdrawal, articles 29 and 30 of the Ivorian Law on the Protection of Personal Data).

The right of opposition is understood to be the possibility offered to Internet users to refuse that their personal information be used for certain purposes mentioned at the time of collection.

The right of withdrawal is the possibility offered to users of our services to request that their personal information no longer appears, for example, in a mailing list.

## **SECURITY**

The personal information we collect is kept in a secure environment. Staff working for us are required to respect the confidentiality of your information.

We are committed to maintaining a high degree of confidentiality by integrating the latest technological innovations to ensure the confidentiality of your transactions. However, since no mechanism offers maximum security, a degree of risk is always present when using the Internet to transmit personal information.
